THIS 17TH SUPPLEMENTAL AGREEMENT is dated $\mu^{t^{T}}$ May 2019 and made

Between:

- (1) Network Rail Infrastructure Limited, ("<u>Network Rail</u>"), a company registered in England under number 2904587 having its registered office at 1 Eversholt Street, London NW1 2DN; and
- (2) Abellio ScotRail Limited, (the "<u>Train Operator</u>"), a company registered in Scotland under number SC450732 having its registered office at 5th Floor, Culzean Building 36 Renfield Street, Glasgow, G2 1LU, United Kingdom.

Background:

- (A) The Train Operator and Network Rail entered into a Track Access Contract (Passenger Services)(which is hereafter referred to as the "Contract") dated 03 March 2016 in a form approved by the Office of Rail and Road pursuant to section 18(7) of the Act.
- (B) The parties now propose to enter into this Supplemental Agreement in order to amend the Contract as described herein.

IT IS HEREBY AGREED as follows:

1. INTERPRETATION

In this Supplemental Agreement:

- 1.1 Words and expressions defined in and rules of interpretation set out in the Contract shall have the same meaning and effect when used in this Supplemental Agreement except where the context requires otherwise;
- 1.2 **"Effective Date**" means the later of the date of signature of this Supplemental Agreement and 0200 on the Subsidiary Change Date 2019.
- 1.3 "Appendix" shall mean the appendices and their relevant parts and attached hereto.

2. EFFECTIVE DATE AND DURATION

The amendments made to the Contract pursuant to this Supplemental Agreement shall have effect from the Effective Date and shall cease to have effect at 0200 on 17 August 2019 or earlier termination of the Contract.

3. ORR GENERAL APPROVAL

This Supplemental Agreement is entered into pursuant to the Passenger Access (Short Term Timetable and Miscellaneous Changes) General Approval 2009.

4. AMENDMENTS TO THE CONTRACT

- 4.1 In table 2.1 of Schedule 5 of the Contract the following entries shall be deleted and replaced with the entries as shown in Appendix A to this Supplemental Agreement:
 - (a) Service 576 (Edinburgh Dunblane Perth in Service Group HA02; and
 - (b) Service 575 (Glasgow Croy Dunblane Dundee (Southbound)) and Service 575 (Glasgow – Croy – Dunblane – Dundee (Northbound)) in Service Group HA07.
- 4.2 In table 2.2 of Schedule 5 of the Contract, the following entries shall be inserted as shown in Appendix B to this Supplemental Agreement:
 - (a) Service 548 (Edinburgh Glasgow) in Service Group HA01; and
 - (b) Service 575 (Glasgow Croy Dunblane Dundee) in Service Group HA07.
- 4.3 In table 2.2 of Schedule 5 of the Contract, the following entries shall be deleted and replaced with the entries as shown in Appendix C to this Supplemental Agreement:
 - (b) Service 536 (Glasgow / Edinburgh Dundee / Arbroath) and Service 576 (Edinburgh Dunblane Perth) in Service Group HA02.
- 4.4 In table 4.1 of Schedule 5 of the Contract, the following tables shall be deleted and replaced with the version shown in Appendix D to this Supplemental Agreement;
 - (a) Service 5870 (Fife Outer Circle (Clockwise)) in Service Group HA02; and
 - (b) Service 575 (Glasgow Croy Dunblane Dundee) in Service Group HA07.

5. EFFECT OF THIS SUPPLEMENTAL AGREEMENT ON THE CONTRACT

The Contract, as amended by this Supplemental Agreement, shall remain in full force and effect in accordance with its terms, and during the period in which the amendments made by this Supplemental Agreement are to have effect all references in the Contract to "the contract", "herein", "hereof", "hereunder" and other similar expressions shall, unless the context requires otherwise, be read and construed as a reference to the Contract as amended by this Supplemental Agreement.

6. LAW

This Supplemental Agreement shall be governed by, construed and given effect to in all respects in accordance with the laws of Scotland.

7. THIRD PARTY RIGHTS

No rights shall be conferred under or arising out of this Supplemental Agreement on any person other than the Parties to this Supplemental Agreement and there shall not be created in any circumstances a jus quaesitum tertio in favour of any person.

8. COUNTERPARTS

This Supplemental Agreement may be executed in any number of counterparts, each of which when executed and delivered shall constitute an original, but all the counterparts shall together constitute one and the same instrument.
