#### Track Access Contract between Network Rail Infrastructure Limited and Direct Rail Services Limited dated 30 August 2009 ("Track Access Contract"): Notice of Consent to Supplements to the Track Usage Price List

Pursuant to paragraph 2.2.10 of Schedule 7 of the Track Access Contract, the Office of Rail Regulation hereby consents to the parties' request made under 2.2.7 of Schedule 7 of the Track Access Contract to supplement the Track Usage Price List to include rates for vehicle type FNAD.

For the purposes of the Track Access Contract, the section of the Track Usage Price List entitled "Freight Spent Nuclear Fuel Freight Only Line Charge rates" shall be supplemented by the inclusion of the vehicle types and corresponding rates set out in Schedule 1 to this notice and the section entitled "Freight Spent Nuclear Fuel Freight Specific Charge rates" shall be supplemented by the inclusion of the vehicle types and corresponding rates set out in Schedule 2 to this notice.

This amendment shall have retrospective effect from the first date that these wagons were used on the Network under the Track Access Contract.

Terms defined in the Track Access Contract shall have the same meaning in this notice. The rates in Schedules 1 and 2 are in 2012/13 prices, consistent with the price base of the Track Usage Price List.
