Notice of statutory consultation on changes to modify the Complaints Handling condition in the licences and SNRPs listed in Annex C to this Notice

ORR hereby gives notice under Section 12(2) of the Railways Act 1993, and Regulation 13(2) of the Railway (Licensing of Railway Undertakings) Regulations 2005, of its proposals to modify the Complaints Handling condition in the licences and Statement of National Regulatory Provisions ("SNRP") listed in Annex C to this Notice. The table in Annex C also sets out the condition number of each individual licence and SNRP that is to be modified. The purpose of the modifications is to require all passenger licence/SNRP holders and station licence holders to become members of an Alternative Dispute Resolution ("ADR") scheme in the rail sector.

Proposed Modifications

The proposed modifications are contained in Annex B to this Notice. The proposed modifications will mean that all passenger licence/SNRP holders and station licence holders must be members of an ADR scheme.

We expect that the proposed modifications for franchise train operators, open access operators and Network Rail will be implemented as soon possible after **1 April 2019**.

For all other rail operators, the proposed modification will be implemented as soon as possible after **1 June 2019**.

Effect and reasons for proposed Modifications

A detailed explanation of the proposed modifications, the effects of those modifications and our reasons for proposing them is set out in our 26 February document "The Rail"



Ombudsman – ORR proposals to modify licence conditions to require membership of an Alternative Dispute Resolution scheme", to which this notice is annexed.

ORR has also discussed its proposals to implement an ADR scheme and to modify the licence/SNRP in detail through the following consultations with industry:

- Changes to Complaints Handling Guidance: Decision letter, dated 8 February 2018¹:
- Modification to Passenger Licence Condition 6 (Complaints Handling) a consultation, dated 26 July 2018²; and
- The Rail Ombudsman ORR proposals to modify licence conditions to require membership of an Alternative Dispute Resolution scheme, dated 19 December 2018³.

Annexed to this notice is:

- i. **Annex B**: containing the proposed modifications to the Complaints Handling condition of the passenger licence/SNRP and station licence. The proposed modification is set out in red; and
- **ii. Annex C:** containing a table of passenger licence/SNRP and station licence holders and showing the condition of their licence where the modification is to be inserted.

We request the consent of licence and SNRP holders in order to make the modifications. We would appreciate licence and SNRP holders sending their written consent to us by 26 March 2019 and that any representations on, objections, or modifications to ORR's proposed changes to the licences listed in Annex C of this Notice should be sent by 26 March 2019 to:

If we do not receive the consent required, we will consider referring the matter to the Competition and Markets Authority under Section 13(1) of the Railways Act 1993 and/or Schedule 3 of the Railway (Licensing of Railway Undertakings) Regulations 2005, as appropriate.

Annex B: Proposed Modification to licences/SNRPs listed at Annex C

We propose that the wording below in red be added to the end of the Complaints Handling condition. The location of the Complaints Handling condition is set out in the table at Annex C to this Notice for each of the licences/SNRPs affected.

- [5 or 7]. (a) The [SNRP] or [licence] holder shall become and thereafter remain, a member of the Relevant ADR Scheme;
 - (b) The [SNRP] or [licence] holder shall comply with its obligations under the Relevant ADR Scheme; and
 - (c) If the Relevant ADR Scheme, at any time, ceases to be Compliant, the [SNRP] or [licence] holder must:
 - (i) within 14 days after becoming aware that the Relevant ADR Scheme is no longer Compliant, notify ORR of that fact;
 - (ii) within no more than 28 days after becoming aware that the Relevant ADR Scheme is no longer Compliant, notify ORR of the arrangements it has put in place to ensure that the interests of passengers are not adversely affected and must, if so directed by ORR at any time, revise those arrangements to take account of any concerns ORR reasonably raises about the protection of passenger interests; and
 - (iii) if the Relevant ADR Scheme continues to be non-Compliant for more than 6 months:
 - take all such steps as are reasonably practicable, including working together with other members of the Relevant ADR Scheme, and Rail Delivery Group, as appropriate, to identify another alternative dispute resolution scheme which is Compliant; and
 - notify such scheme to ORR within not more than 12 months (or such longer period as ORR may agree) after the date on which the Relevant ADR Scheme ceased to be Compliant

[6 or 8]. For the purposes of this Condition:

"Relevant ADR Scheme" means:

- the alternative dispute resolution scheme procured by Rail Delivery Group (the Rail Ombudsman) or, as the case may be, any Successor Scheme

"Successor Scheme" means:



- such other alternative dispute resolution scheme as is notified to ORR by the [SNRP] or [licence] holder under sub-paragraph (c)(iii) above, and is accepted by ORR as providing suitable protection for the interests of passengers.

"Compliant", in relation to the Relevant ADR Scheme, means:

 that the scheme is approved by the Designated Competent Authority and meets the requirements of ORR's Guidance in respect of an alternative dispute resolution scheme.

"Designated Competent Authority" means:

 the relevant Designated Competent Authority under The Alternative Dispute Resolution for Consumer Disputes (Competent Authorities and Information) Regulations 2015

"ORR's Guidance" means:

 ORR's Guidance on the Complaints Handling Procedures as amended from time to time.
