APPROVAL OF PROPOSAL FOR CHANGE 63 RELATING TO PART A OF THE NETWORK CODE

1. The Office of Rail Regulation has today approved Proposal for Change (PfC) 63 to Part A of the Network Code, which was submitted to it by the Class Representative Committee (CRC) on 31 May 2012.
2. This proposal, which we sponsored, implements a change to Part A of the Network Code to update the methods by which a notice, consent or approval can be served on parties. The proposed Part A covers all forms of issuing notice, including electronic means.
3. We have participated in the development of the amendments and have considered and commented on them at all stages. We have reviewed the consultation responses received and considered by the CRC at its meeting on 29 March 2012.
4. This approval is consistent with our statutory duty to enable persons providing railway services to plan the future of their businesses with a reasonable degree of assurance.
5. In accordance with Condition C9.1.2 of the Network Code, the amendments to Part A of the Network Code shall have effect 14 days from the date of this notification.
6. In giving CRC notice of approval we also copy this letter and attached notice to all parties identified under Conditions A4.1 and C9.1.1 of the Network Code.
7. A copy of this letter, the approval notice and the proposals will be placed on the ORR website. A copy of the approval notice will also go on ORR's public register.

NOTICE OF APPROVAL OF CHANGE TO PART A OF THE NETWORK CODE

1. This notice is given under Condition C7.1.3 of the Network Code. Terms defined in the Network Code have the same meaning in this notice. References in this notice to Conditions are references to Conditions of the Network Code.
2. The Class Representative Committee (CRC) submitted Proposal for Change 63 under Condition C7.1.1 on 31 May 2012. The CRC has also submitted a written memorandum explaining the reasons for the proposed changes and details of the result of the consultation process as required by Condition C7.1.1.
3. The Secretary to the CRC has informed me that the Proposal for Change was unanimously endorsed by the CRC at its meeting on 29 March 2012.
4. ORR now gives notice to the CRC that it approves Proposal for Change 63 for the purpose of Condition C7.1.3.
