NOTICE OF APPROVAL OF AMENDMENTS TO THE SEPTEMBER 2013 DELAY ATTRIBUTION GUIDE

1. This notice is given under Condition B2.7.2 of the Network Code. Terms defined in the Network Code have the same meaning in this notice. References in this notice to Conditions are references to Conditions of the Network Code.
2. Dated 4 February 2014 the Delay Attribution Board (“DAB”) submitted a number of Proposals for Amendment (set out in a schedule to this notice) to ORR in accordance with Condition B2.7.1
3. The Secretary to the DAB has confirmed the reasons for the proposed amendments and these have been accepted by the DAB following the consultation process, as required by Condition B2.7.1.
4. ORR now gives notice to the DAB that it approves the Proposals for Amendment as set out in a schedule to this notice for the purpose of Condition B2.7.2. The amendments will take effect on 1 April 2014 in the document to be known as the April 2014 Delay Attribution Guide.
5. A schedule of the approved Amendments to the Delay Attribution Guide is attached to this notice.
