

Errata: Periodic review of HS1 Ltd 2024 - final determination

Published 5 February 2025

Following publication of our Final Determination on 6 January, HS1 Ltd has updated its Five Year Asset Management Statement (5YAMS) and Life Cycle Reports (LCRs) for CP4, including associated changes to its underlying models. In the process of updating its models, HS1 identified that we had made a small error in the use of our forecast international train volumes in the modelling used for the Final Determination. This does not materially impact the headline charges, but does have a small impact on the tables below in our Final Determination, notably a small change to the split of charges between international and domestic paths, and a small reduction in some elements of the charge per train.

*Our Final Determination recognised that HS1 Ltd may decide to profile our determined efficiencies differently, with more efficiencies later or earlier in the control period, and that a non-flat profile of efficiencies may incur additional cost of capital for HS1 Ltd in years where costs exceed charges. HS1 Ltd's profiling of these O&M efficiencies in its response to our Final Determination results in an increase of £74k in financing, equivalent to a 0.01% increase in the total OMRC to be recovered from operators, and an increase of £0.08 (0.02%) to operators' OMRCB £/min charge. We have reviewed HS1 Ltd's revised profile and we are satisfied that it is consistent with our Final Determination and does not materially impact charges.
