## NOTICE OF AGREEMENT: FRANCHISED PASSENGER TRACK ACCESS CHARGES

- TO: Each of the persons listed in the annex to this notice of agreement (the "**relevant** beneficiaries").
  - 1 This notice of agreement is given under paragraph 5(1) of Schedule 4A to the Railways Act 1993 (the "**Act**").
  - 2 On 18 December 2008, the Office of Rail Regulation ("**ORR**") gave a review notice specifying the relevant changes (within the meaning of Schedule 4A to the Act) which the ORR proposed to make for or in connection with giving effect to the ORR's conclusions on a review of:
    - (a) the amounts payable by Network Rail Infrastructure Limited and each of the relevant train operators to each other under each of the access agreements identified in the annex to this notice of agreement; and
    - (b) the times at which, and manner in which, those amounts are payable,

(the "2008 franchised passenger track access review notice").

- 3 Copies of the 2008 franchised passenger track access review notice were served on each of Network Rail Infrastructure Limited, the Secretary of State, the Scottish Ministers, the Treasury and the persons specified in Annex 1 to that notice.
- 4 The 2008 franchised passenger track access review notice specified that any objections by any persons specified in paragraph 4(4)(a) or (b) of Schedule 4A to the Act with respect to:
  - (a) any of the proposed relevant changes; or
  - (b) the date on which it is proposed that any of the proposed relevant changes should come into operation,

should be made in writing on or before 5 February 2009.

5 ORR now gives notice that no such objections have been made.
